Any eligible Premium fixture that fails to perform as designed will be repaired or replaced at no charge for as long as the club membership is in good standing. Failure of fixtures through abuse, misuse, neglect, vandalism, freezing, or earthquake will not be covered. The results of ordinary wear and tear, such as scratches and blemishes, will not constitute cause for replacement.

To ensure trouble-free operation of eligible fixtures/ equipment, we must thoroughly inspect your plumbing system at least once a year and your HVAC system twice per year. During this visit, your Bannister Plumbing & Air technicians will make necessary adjustments, repairs, or replacements of eligible fixtures at absolutely no cost to you. It is the responsibility of the Club member to schedule this inspection. Your valid email address will allow us to send reminders to schedule visits and communicate credit-card processing errors should they occur.

Fixture installations must comply with local codes. Other conditions may be required for eligibility as determined by your Bannister Plumbing & Air technician. These conditions may include but are not limited to installation of emergency shutoff valves, pressure-reducing valves, waste or potable water-line repairs, surge protectors, system condition. Maintenance or alteration of eligible fixtures by anyone other than your Bannister Plumbing & Air technician may void warranty.
